

LETTER FROM THE EXECUTIVE DIRECTOR, MIKE RILEY

CLIMATE LEADERSHIP, LOCALLY AND BEYOND

Wild weather is once again racking many parts of the nation. Extreme heat waves, major rains and floods, and major storms in the Midwest and New York. Here at home, major drought prevails across much of central and eastern Oregon, despite the recent rain. Once again, our warming climate is showing us an unpleasant reality, just as the scientists predicted.

Our staff work hard to reduce local contribution to climate pollution. While we may no longer be able to stop

some amount of warming, we still have time to prevent the worst case scenarios, locally and globally. Here are a few ways that we are doing our part.

Lindsey Hardy is advocating for the Bend City Council to adopt a mandatory Home Energy Score for new and existing homes so they become more energy efficient. The Bend transportation bond that we helped pass in November 2020 is finally leading to real projects on the ground. Most exciting of all is the Wilson Avenue Corridor project, which will include the first protected bike lanes in Bend's history and set a new standard for the rest of the community.

Two of our staff are serving on statewide policy committees related to climate. Neil Baunsgard was appointed by the legislature to the Joint Task Force on Resilient Efficient Buildings, which is developing policy change recommendations that will decarbonize new and existing construction to help meet Oregon's climate goals. Also, Udara Abeysekera Bickett was recently appointed to an advisory committee that will provide input on implementation of the Plastic Pollution and Recycling Modernization Act of 2021. Our Youth Education team is creating new opportunities to develop youth leaders. Jackie Wilson recently took two local high school students, Riley Ahmuty and Karen Pelayo, on an expedition to Alaska to recover

plastic from ocean beaches and learn about the impact of plastics on the marine environment. They removed over 5 tons of plastic from beaches in Katmai National Park, developed their independence and teamwork skills, and got connected to a bigger world and to professionals working in the environmental field. Karen will be one of the co-leaders of the student-led and TEC-supported Green Leadership Coalition this coming school year.

A FIELD TRIP THREE YEARS IN THE MAKING!

Back in 2019, we were excited to receive an Oregon Farm to School grant, funding a series of farm field trips in collaboration with Tumalo-based Sakari Farm. The first visit was planned for Spring 2020...and well, you know what happened. We got creative and spent four planting and harvesting seasons filming virtual field trips for students to watch and learn from. But it was not the hands-on experience we'd hoped for.

This June, with great excitement, we were finally able to bring 50 fourth graders from Lynch Elementary School in Redmond to experience Sakari Farms in person! It was an incredible day full of learning, tasting, planting, and playing. Farm Owner Spring led students on a farm tour, where they discovered greenhouses, compost, traditional Native crops, pollinators, and more. Next, our FoodCorps Service Member Adrienne, who has been leading lessons in students' classrooms and in the garden since the beginning of the year, offered mindful tastings of arugula, kale, cilantro, and

edible flowers. For their third farm activity, students got their hands dirty and each planted a cherry tomato plant. When they return as fifth graders, we hope they are able to harvest these tomatoes to bring back to school and share with the rest of the students.



RETHINK WASTE PROJECT GETS A SEAT AT THE TABLE

We are proud to announce that our Rethink Waste Project Program Manager, Udara Abeysekera Bickett, has been appointed by the Oregon Department of Environmental Quality to serve on the Rulemaking Advisory Committee to represent the diverse interests of persons and communities likely to be affected by proposed rules in the Plastic Pollution and Recycling Modernization Act of 2021. Here are Udara's thoughts on this exciting undertaking:

Q: What can you tell us about the Recycling Modernization Act?

The Plastic Pollution and Recycling Modernization Act (RMA) will make updates to Oregon's recycling system, making recycling easier for the public to use, expand access to recycling services, upgrade the facilities that sort recyclables, and more. Producers of packaging, paper products and food serviceware that sell into Oregon will share the financial responsibility of managing all their "stuff."

Q: What issues or topics are you most concerned about when it comes to plastic pollution and waste?

The role of plastics in the climate crisis is one of my biggest concerns. Virtually all plastics are made of fossil fuels. Plastics pollute and produce greenhouse gasses even in the manufacturing stage of their life as these fossil fuels are dug up. As a result, the U.S. plastics industry's contribution to climate change is on track to exceed that of coal-fired

power in this country by 2030. This is why I believe the biggest impact we can have is in reducing plastics in the first place.

Q: What do you hope to take away from this experience?

This is my first time serving on a state-level committee and I am looking forward to learning about the decision making processes. This is also one of the first state-wide laws of its kind covering topics like Statewide Collections List, Truth in Labeling, and Producer Responsibility. I hope that the success of the Oregon RMA can be a model for recycling system updates in other states as well.

species. The expedition will have a ripple effect, as these two students are now sharing what they learned and plan to work within their high schools next year to create change:

"Coming back to Bend from the Katmai expedition with the Ocean Plastic Recovery Project has been super interesting in that my lens at the grocery store, school and around my house is a lot more mindful of plastic consumption [...] Although we worked five long days and collected IO,OOO lbs of plastic waste, that is not even a dent in what litters the world's beaches; the greatest impact we have made is the knowledge we now have to share with our communities and influence change in plastic consumption." - Riley A.

"I'm really happy and excited that I have another year in Bend and that my school's club elected me as president for the following year because this project has inspired me. My goals for the year will be to educate others. Now that I have this experience, I'm able to speak from a personal level and hopefully help people evolve their mindset and understand the significance of taking care of our planet." - Karen P.

Help Us Move Forward The Home Energy Score Ordinance

The Home Energy Score (HES) Ordinance would require all homes being sold in Bend to receive an energy score reflecting the home's overall efficiency at the time of listing.

What are the benefits?

- Increased transparency in the homebuying process
- Informs consumers of the true costs of homeownership
- Allows for a level comparison of energy use across the housing market

This proven standardized process helps homebuyers contribute to reducing carbon emissions by giving them a prioritized list of energy improvements that can be made to their homes at the time when they are most likely to make upgrades to the residences.

What is the timeframe?

- Summer 2022 Community input on draft ordinance*
- Fall 2022 Council votes on ordinance*
- Summer 2023 HES program implemented

*These will be critical times to show your support to get this important policy passed. Be on the lookout for upcoming calls to action for you, our community, to help spread the word and advocate for this much needed change.
